

J. ERROR MESSAGES

This appendix includes an explanation of the possible edit errors identified by the FCR in processing input transactions. Appendix G, “FCR Input Transaction Layouts”, describes the FCR Input Transaction Layouts. The FCR edits each transaction that is received to detect critical and non-critical edit failures. The system rejects transactions that fail critical edits and returns the records with the appropriate error codes. The system also returns warning messages and associated records to the submitter when the FCR accepts a transaction, but the record fails a non-critical edit. If a record has a combination of critical and non-critical edit failures, the system returns both error and warning codes.

This appendix lists, for each edit, the Error Code, Record Type (for non-transmission errors) and the Error Message and Description. The errors are listed in alphanumeric order. Charts J-1, “FCR Transmission Error and Warning Codes”, and J-2, “FCR Record Error and Warning Codes”, list, for each edit, the Error Code and the Error Message/Description. Batch Transmission error codes are four positions long. The transaction error codes are five positions long. An ‘E’ is in the second position of the transaction error code, if the edit results in a rejection. A ‘W’ is in the second position of the transaction error code, if the edit is a warning. The Batch Transmission error codes are listed first in the appendix followed by the transaction error codes. The transaction error codes are listed in alphanumeric order for easy reference. The second column of the table for the transaction error codes includes one or more of the following codes to indicate the FCR input record associated with the error code.

Chart J-3, “FCR Data Inconsistency Warning Codes”, includes an explanation of the data inconsistency warning codes that are returned when a state requests the FCR Data Inconsistency File and there are inconsistencies on the FCR between the Participant Type, Order Indicator, Date of Birth and Sex Code. The warning codes on Chart J-3 are returned for Person and Case Records that already reside on the FCR and are not performed on input transactions. Section 10.3, “FCR Data Inconsistency File”, provides additional information on the processing of data inconsistencies by the FCR.
