

eCSE - Interstate Objectives

- ◆ Provide 24/7 access to interstate customers & other state workers
- ◆ Demonstrate the portability of 'Open Source' technologies to promote interactive CSE web access
- ◆ Demonstrate the possibility of secure state-to-state data sharing through web services

eCSE for Interstate Customers

- ◆ As of 8/30/04 - over 2100 cases from outside of Colorado were registered for access to eCSE
- ◆ States with most registrations:
 - Texas – 246
 - California – 163
 - Arizona – 148
 - Florida - 131

eCSE for Other State Workers

- ◆ Currently CSE Workers must complete a privacy form to register
- ◆ 103 other state workers currently signed up –

eCSE - A Portable Solution

- ◆ CO shared its 'Open source web technologies' with AZ to promote more sharing of case / financial info
 - Our approach
 - Our toolkit
 - Our inspiration
- ◆ AZ Interactive Web application went live Sept. 1, 2004

Sharing through web services

- ◆ Conducting a pilot project with Arizona
- ◆ Intended to allow access to case and financial data from each other's CSE system via the web for workers
- ◆ Security agreement will be reached
- ◆ Will use industry standards, protocol
